Whereas, the procurement process had been conducted but there was a short of award due to the pending authority to procure from the Department of Budget and Management, per DBM Guideline No. _____;

Whereas, there were three (3) bidders who submitted their letters of intent and sealed bids for the **supply and delivery of Twenty-Two (22) units 4WD Tractor with Complete Accessories** with the **Approved Budget for the Contract (ABC)** of **Fifty-Five Million Pesos (Php55,000,000.00)** as the **100% cost of the project**, i.e.:

Whereas, after thorough deliberation of the bids and awards committee based on the evaluation reports of the technical working group, it was found out that **Filholland Corporation** met the minimum requirements of the Procuring Entity and its proposal in the amount of **Fifty-Two Million Four Hundred Thirty-Two Thousand Six Hundred Sixty-Five Pesos and 56/100 (Php52,432,665.56)** representing the **100% amount of the project** and was determined the **Lowest Calculated Bid**. Whereas, the project shall be on **90/10% scheme wherein the Ninety percent (90%) amount of the project** shall be paid by the procuring entity as **DA's counterpart** and the **Ten percent (10%) amount shall be the recipient's equity**;
