**Whereas**, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Phela Grande Hotel, Incorporated** in the amount of **Five Hundred Thirty-One Thousand Pesos (Php531,000.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;



**WHEREFORE**, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **provision of food and accommodation for the conduct of 2016 Regional Sikat Saka Rice Congress cum Trade Fair and Exhibits** in the amount of **Five Hundred Thirty-One Thousand Pesos (Php531,000.00)** which is the **Single Calculated and Responsive Bid**, be awarded to **Phela Grande Hotel, Incorporated.**


