Whereas, a public bidding was conducted on November 3, 2015 at 9:00 am in the DA RFO 12 conference room, Zulueta Street, Koronadal City. It was presided by the BAC Chairman;

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bids for the **Delivery and Installation of Three (3) units Corn Mill** with the **Approved Budget for the Contract (ABC) of Three Million Nine Hundred Thousand Pesos (Php3,900,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Payo Manufacturing Corporation** in the amount of **Three Million Eight Hundred Forty-Three Thousand Eight Hundred Forty Pesos (Php3,843,840.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Payo Manufacturing Corporation** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;

Whereas, Section 36, letter a, Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:


- a. *If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"*


Whereas, Section 34.4 Rule X of RA 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"


Whereas, the bid amount submitted by Payo Manufacturing Corporation which is advantageous to the government is Three Million Eight Hundred Forty-Three Thousand Eight Hundred Forty Pesos (Php3,843,840.00);


