Whereas, a public bidding was conducted last December 1, 2015 at 9:00 am in the DA RFO 12 conference room, Zulueta Street, Koronadal City. It was presided by the BAC chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bids for the supply and delivery of One (1) unit 4WD Tractor with Backhoe with the Approved Budget for the Contract (ABC) of One Million Six Hundred Fifty Thousand Pesos (Php1,650,000.00), i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Filholland Corporation** in the amount of **One Million Six Hundred Twenty-Six Thousand Two Hundred Forty Pesos (Php1,626,240.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Filholland Corporation** it was determined that the latter was technically, legally and financially eligible and was Post-Qualified for the said project. Thus, its bid was declared as **Single Calculated and Responsive Bid**;

Whereas, the bid amount submitted by Filholland Corporation which is advantageous to the government is One Million Six Hundred Twenty-Six Thousand Two Hundred Forty Pesos (Php1,626,240.00);

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the Supply and delivery of One (1) unit 4WD Tractor with Backhoe in the amount of One Million Six Hundred Twenty-Six Thousand Two Hundred Forty Pesos (Php1,626,240.00) which is a Single Calculated and Responsive Bid, be awarded to Filholland Corporation.
