Whereas, a public bidding was conducted last December 22, 2015 at 9:00 am in the DA RFO 12 conference room, Zulueta Street, Koronadal City. It was presided by the BAC chairman.

Whereas, there were two (2) bidders who submitted their letters of intent and sealed bids for the **Supply and Delivery of Assorted Motor Pool Tools and Equipment** with the **Approved Budget for the Contract (ABC) of One Million Six Hundred Eight Thousand Pesos (Php1,608,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Work Essentials Trading** in the amount of **One Million One Hundred Forty-Seven Thousand One Hundred Pesos (Php1,147,100.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Work Essentials Trading** it was determined that the latter was technically, legally and financially eligible and its bid was declared as **Single Calculated and Responsive Bid**;


