RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 12 AND ROCEL LIVESTOCK FARM FOR THE SUPPLY AND DELIVERY OF POULTRY/LIVESTOCK ANIMALS WITH THE BID PRICE OF PHP 595,273.19.

Whereas, the Department of Agriculture - Regional Field Office No. 12, Koronadal City under the Agri-Pinoy Rice Program CY 2014 Fund has a procurement, i.e.; **Supply and delivery of Poultry/Livestock Animals with the Approved Budget for the Contract (ABC) of Six Hundred Sixteen Thousand Two Hundred Fifty Pesos (Php616,250.00)**;

Whereas, there were already **two (2) failures of bidding** for the said project per Resolution No. 2015-004A and 2015-007A dated January 19, 2015 and February 23, 2015, respectively;

Whereas, Section 35, 35.5, Rule X of RA 9184 states that **"Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 of this IRR;**

Whereas, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last December 10, 2015;

Whereas, the Bids and Awards Committee (BAC) invited **three (3) eligible bidders** for the Negotiated Procurement of the said project, namely:

1. AB Livestock Supplier in Tacurong City;
2. Rocel Livestock Farm in Sto. Niño, South Cotabato; and
3. PCS Livestock Ventures in Kidapawan City.

Whereas, in the opening of sealed bids for negotiated procurement conducted last December 22, 2015 - 9:00AM at DA-12 Conference Room, Koronadal City, there was only one (1) bidder submitted its Request for Extension of Interest (REOI) and sealed bids, namely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **Rocel Livestock Farm** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

Whereas, Section 36 (a), Rule X of RA 9184 states that a single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"

Whereas, Section 34, 34.4, Rule X of RA 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, xxx";


Whereas, the bid amount (as calculated) offered by Rocol Livestock Farm which is advantageous to the government is **Five Hundred Ninety-Five Thousand Two Hundred Seventy-Three Pesos and 19/100 (Php595,273.19)**;

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of Poultry/Livestock Animals** in the amount of **Five Hundred Ninety-Five Thousand Two Hundred Seventy-Three Pesos and 19/100 (Php595,273.19)** be negotiated to **Rocol Livestock Farm** as the bidder who submitted the **Single Calculated and Responsive Bi.**


