Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Super Trade Enterprises** in the amount of **Three Million Ninety Thousand Seven Hundred Pesos (Php3,090,700.00)** met the minimum requirements and was determined as the **Lowest Calculated Bid**.
