**Whereas**, a public bidding was conducted last December 28, 2015 at 10:00 am in the DA 12 Conference Room, Koronadal City. It was presided by the BAC Chairman.

**Whereas**, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **supply and delivery of Forty (40) units Patak Ani Drip Irrigation System (Hose)** with the **Approved Budget for the Contract (ABC) of Two Million Pesos (Php2,000,000.00)**, i.e.:

**Whereas**, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Harbest Agribusiness Corporation** in the amount of **Seven Hundred Twenty-Eight Thousand Pesos (Php728,000.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;



- a. *If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx*


WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of Forty (40) units Patak Ani Drip Irrigation System (Hose)** in the amount of **One Million Nine Hundred Eighty Thousand Pesos (Php1,980,000.00)** which is the **Single Calculated and Responsive Bid**, be awarded to **Harbest Agribusiness Corporation**.


