Whereas, a public bidding was conducted last December 28, 2015 at 10:00 am in the DA RFO 12 conference room, Zulueta Street, Koronadal City. It was presided by the BAC chairman.

Whereas, there were four (4) bidders who submitted their letters of intent and sealed bids for the **Supply and Delivery of Various Fertilizers with the Approved Budget for the Contract (ABC) of Five Million Fifty Thousand Pesos (Php5,050,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Modern Time Enterprises, Inc.** in the amount of **Three Million Four Hundred Eighty-Nine Thousand Six Hundred Fifty Pesos (Php3,489,650.00)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;


Whereas, per post-qualification of all the submitted documents of **Modern Time Enterprises, Inc.** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;


Whereas, Section 34.4 Rule X of RA 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"


