Whereas, a public bidding was conducted last February 3, 2016 at 9:00 am in the Villa Amor Hotel, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the supply and delivery of Twenty-Eight (28) units Corn Mill with the Approved Budget for the Contract (ABC) of Nine Million Eight Hundred Pesos (Php9,800,000.00), i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by Suki Trading Corporation in the amount of Nine Million Four Hundred Eighty-Three Thousand Six Hundred Pesos (Php9,483,600.00) met the minimum requirements and was determined as a Single Calculated Bid. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of Suki Trading Corporation it was determined that the latter was technically, legally and financially eligible and its bid was declared as a Single Calculated and Responsive Bid;

Whereas, Section 36, letter a, Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a. If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the supply and delivery of Twenty-Eight (28) units Corn Mill in the amount of Nine Million Four Hundred Eighty-Three Thousand Six Hundred Pesos (Php9,483,600.00) which is the Single Calculated and Responsive Bid, be awarded to Suki Trading Corporation.
