Whereas, a public bidding was conducted last March 14, 2016 at 10:00 am in the DA-12 Conference Room, Koronadal City. It was presided by the BAC Chairman.

Whereas, there were two (2) bidders who submitted their letters of intent and sealed bids for the **supply and delivery of Various Agricultural Supplies** with the **Approved Budget for the Contract (ABC) of Seven Hundred Ninety-Two Thousand Five Hundred Sixty Pesos (Php792,560.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Modern Time Enterprises, Inc.** in the amount of **Seven Hundred Fifty Thousand Seven Hundred Fifty Pesos and 11/100 (Php750,750.11)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Modern Time Enterprises, Inc.** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;


Whereas, Section 34.4 Rule X of RA 9184 states that "The BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"

Whereas, the bid amount submitted by Modern Time Enterprises, Inc. which is advantageous to the government is **Seven Hundred Fifty Thousand Seven Hundred Fifty Pesos and 11/100 (Php750,750.11)**;

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of Various Agricultural Supplies** in the amount of **Seven Hundred Fifty Thousand Seven Hundred Fifty Pesos and 11/100 (Php750,750.11)** which is the **Lowest Calculated Responsive Bid**, be awarded to **Modern Time Enterprises, Inc.**






