Whereas, a public bidding was conducted last March 14, 2016 at 10:00 am in the DA-FRO 12, Conference Room, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **provision of Sixteen (16) head Security Guard (Blue Guard)** with the **Approved Budget for the Contract (ABC)** of One **Million Five Hundred Seventy-Six Thousand Seven Hundred Ninety-One Pesos and 36/100 (Php1,576,791.36)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Supreme Investigative & Security Agency** in the amount of One **Million Five Hundred Fifty-Eight Thousand Six Hundred Sixty-Eight Pesos and 24/100 (Php1,558,668.24)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Supreme Investigative & Security Agency** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;


Whereas, Section 36, letter a, Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a. If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"


