Whereas, a public bidding was conducted last April 12, 2016 at 9:00 am in the Da-12 Conference Room, Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **supply and delivery of 600,000 pcs Coffee Planting Materials** with the **Approved Budget for the Contract (ABC) of Four Million Six Hundred Eighty Thousand Pesos (Php4,680,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **La Suerta's Fruit Trees Nursery** in the amount of **Four Million Six Hundred Twenty Thousand Pesos (Php4,620,000.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **La Suerta's Fruit Trees Nursery** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;




