Whereas, the Department of Agriculture – Regional Field Office No. 12, Koronadal City under the Corn Program CY 2016 Fund has a project, i.e.; **Supply and delivery of 466 bags Hybrid Corn Seeds** with the Approved Budget for the Contract (ABC) of **One Million Eight Hundred Sixty-Four Thousand Pesos (P1,864,000.00)** at **Four Thousand Pesos (P4,000.00)** per bag;

Whereas, a public bidding for the **Supply and delivery of 466 bags Hybrid Corn Seeds** with the Approved Budget for the Contract (ABC) of **One Million Eight Hundred Sixty-Four Thousand Pesos (P1,864,000.00)** at **Four Thousand Pesos (P4,000.00)** per bag was scheduled last September 27, 2016 – 9:00AM at DA-12 Conference Room (2<sup>nd</sup> Floor), Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairperson;

Whereas, there were five (5) bidders who submitted their letters of intent and sealed bids for the **“Supply and delivery of 466 bags Hybrid Corn Seeds”** with the Approved Budget for the Contract (ABC) of **One Million Eight Hundred Sixty-Four Thousand Pesos (P1,864,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **RJR Agro-Industrial Enterprises** in the amount of **Seven Hundred Ninety-Two Thousand One Hundred Twenty Pesos and 78/100 (Php792,120.78)** at **One Thousand Six Hundred Ninety-Nine Pesos and 83/100 Centavos (P1,699.83)** per bag met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **RJR Agro-Industrial Enterprises** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;


Whereas, Section 34.4, Rule X of RA 9184 partly states that, "*If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated and Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, Xxx.*"

Whereas, the bid amount (as calculated) offered by **RJR Agro-Industrial Enterprises** which is advantageous to the government is **Seven Hundred Ninety-Two Thousand One Hundred Twenty Pesos and 78/100 (Php792,120.78)** at **One Thousand Six Hundred Ninety-Nine Pesos and 83/100 Centavos (P1,699.83)** per bag;


WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the **Supply and delivery of 466 bags Hybrid Corn Seeds** in the amount of **Seven Hundred Ninety-Two Thousand One Hundred Twenty Pesos and 70/100 (Php792,120.78)** at **One Thousand Six Hundred Ninety-Nine Pesos and 83/100 Centavos (P1,699.83)** per bag be awarded to **RJR Agro-Industrial Enterprises** as the bidder who submitted the **Lowest Calculated Responsive Bid**.




