Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Suki Trading Corporation** in the amount of **Two Million Four Hundred Thirty-Two Thousand Pesos (Php2,432,000.00)** met the minimum requirements and was determined as the **Lowest Calculated Bid**.
