Whereas, a public bidding for the procurement of Eight (8) Units Vertical Dryer was scheduled last February 3, 2016 at 9:00 am, was held in Villa Amor Hotel and Restaurant, Cansan Drive, Koronadal City;

Whereas, the project shall be on 90/10 scheme wherein the ninety percent (90%) amount of the project shall be paid by the procuring entity as DA's counterpart and the ten percent (10%) amount of the project shall be the recipient's equity;

Whereas, the one hundred percent (100%) amount of the project is Twenty-Eight Million Pesos (Php28,000,000.00) at Three Million Five Hundred Thousand Pesos (Php3,500,000.00) Per Unit as the Approved Budget for the Contract;

Whereas, there was only one (1) Bidder who submitted its letter of intent and sealed bid for the supply and delivery of Eight (8) Units Vertical Dryer, i.e:

Whereas, after thorough deliberations of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), it was determined that All Certified Equipment Trading Corp. met the minimum requirements and was declared as the bidder who submitted the Single Calculated Bid and was subjected for Post-qualification;

Whereas, per post-qualification reports of the BAC and TWG, the bid of All Certified Equipment Trading Corp. in the amount of Twenty-Seven Million Nine Hundred Eighteen Thousand Eight Hundred Eighty-Eight Pesos (Php27,918,888.00) was declared as the Single Calculated and Responsive Bid (SCRB);

Whereas, the breakdown of bid tendered by All Certified Equipment Trading Corp. for the said project is shown below;






Whereas, the ten percent (10%) amount of the project amounting to Two Million Seven Hundred Ninety-One Thousand Eight Hundred Eighty-Eight Pesos and 80/100 (Php2,791,888.80) at Three Hundred Forty-Eight Thousand Nine Hundred Eighty-Six Pesos and 10/100 (Php348,986.10) per unit shall be the Recipients' Equity;

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity that the supply and delivery of the Eight (8) Units Vertical Dryer in the amount of Twenty-Five Million One Hundred Twenty-Six Thousand Nine Hundred Ninety-Nine Pesos and 20/100 (Php25,126,999.20) at Three Million One Hundred Forty Thousand Eight Hundred Seventy-Four Pesos and 90/100 (Php3,140,874.90) per unit, representing the 90% amount of the project which shall be paid by the procuring entity as DA's counterpart be awarded to All Certified Equipment Trading Corp.
