**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF 6,441 BAGS CERTIFIED PALAY SEEDS (BUFFER STOCKING - HIGH QUALITY SEED) WITH THE BID PRICE OF EIGHT MILLION SEVEN HUNDRED FIFTY-EIGHT THOUSAND EIGHT HUNDRED FIFTY-EIGHT PESOS AND 26/100 (PHP8,758,858.26).**

**Whereas**, a public bidding was conducted last February 3, 2016 at 9:00 am in the Villa Amor Hotel, Koronadal City. It was presided by the BAC Chairman.

**Whereas**, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **supply and delivery of 6,441 bags Certified Palay Seeds (Buffer Stocking - High Quality Seed)** with the **Approved Budget for the Contract (ABC) of Eight Million Seven Hundred Fifty-Nine Thousand Seven Hundred Sixty Pesos (Php8,759,760.00)**, i.e.:

**Whereas**, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Davao Oriental Seed Producers Cooperative (DOSEPCO)** in the amount of **Eight Million Seven Hundred Fifty-Eight Thousand Eight Hundred Fifty-Eight Pesos and 26/100 (Php8,758,858.26)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

**Whereas**, per post-qualification of all the submitted documents of **Davao Oriental Seed Producers Cooperative (DOSEPCO)** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;

Whereas, Section 36, letter a, Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a. If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"

Whereas, Section 34.4 Rule X of RA 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"

Whereas, the bid amount submitted by Davao Oriental Seed Producers Cooperative (DOSEPCO) which is advantageous to the government is Eight Million Seven Hundred Fifty-Eight Thousand Eight Hundred Fifty-Eight Pesos and 26/100 (Php8,758,858.26);

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HIOPE) that the supply and delivery of 6,441 bags Certified Palay Seeds (Buffer Stocking - High Quality Seed) in the amount of Eight Million Seven Hundred Fifty-Eight Thousand Eight Hundred Fifty-Eight Pesos and 26/100 (Php8,758,858.26) which is the Single Calculated and Responsive Bid, be awarded to Davao Oriental Seed Producers Cooperative (DOSEPCO).


