Whereas, there were two (2) bidders who submitted their letters of intent and sealed bids for the supply and delivery of 611,875 pcs Rubber Planting Materials with the Approved Budget for the Contract (ABC) of Twenty-Four Million Four Hundred Seventy-Five Thousand Pesos (Php24,475,000.00), i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by Binahon Agroforestry Farm in the amount of Twenty-Four Million Four Hundred Thirteen Thousand Eight Hundred Twelve Pesos and 50/100 (Php24,413,812.50) met the minimum requirements and was determined as the Lowest Calculated Bid. Therefore, subjected for Post-Qualification;
