Whereas, a public bidding was conducted last February 4, 2016 at 9:00 am in the Villa Amor Hotel, Koronadal City. It was presided by the BAC Chairman.

Whereas, there were two (2) bidders who submitted their letters of intent and sealed bids for the **supply and delivery** of 1,044 cans Upland Vegetable Seeds with the **Approved Budget for the Contract (ABC)** of Two Million Six Hundred Ten Thousand Pesos (Php2,610,000.00), i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Seedworks Philippines, Inc.** in the amount of **One Million Seven Hundred Ninety-Eight Thousand Five Hundred Sixty-Nine Pesos and 48/100 (Php1,798,569.48)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Seedworks Philippines, Inc.** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;

Whereas, the bid amount submitted by Seedworks Philippines, Inc. which is advantageous to the government is One Million Seven Hundred Ninety-Eight Thousand Five Hundred Sixty-Nine Pesos and 48/100 (Php1,798,569.48);

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HIOPE) that the supply and delivery of 1,044 cans Upland Vegetable Seeds in the amount of One Million Seven Hundred Ninety-Eight Thousand Five Hundred Sixty-Nine Pesos and 48/100 (Php1,798,569.48) which is the Lowest Calculated Responsive Bid, be awarded to Seedworks Philippines, Inc.


