Whereas, a public bidding was conducted last February 29, 2016 at 9:00 am in the DA - RFO12 Conference Room, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the supply and delivery of 900,000 cuttings Sweet Potato with the Approved Budget for the Contract (ABC) of Nine Hundred Thousand Pesos (Php900,000.00), i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Kooperatiba ng Magsasakang Pilipino ng Timog Kutabato (KOMATIKU)** in the amount of **Nine Hundred Thousand Pesos (Php900,000.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;


Whereas, per post-qualification of all the submitted documents of **Kooperatiba ng Magsasakang Pilipino ng Timog Kutabato (KOMATIKU)** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;


Whereas, Section 36, letter a, Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a. If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"


WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the supply and delivery of **900,000 cuttings Sweet Potato** in the amount of **Nine Hundred Thousand Pesos (Php900,000.00)** which is the **Single Calculated and Responsive Bid**, be awarded to **Kooperatiba ng Magsasakang Pilipino ng Timog Kutabato (KOMATIKU)**.


