**CONTRACT**

KNOW ALL MEN BY THESE PRESENTS: FEB 23 2016

This contract made and entered this \_\_\_\_ day of \_\_\_\_\_ by and between the **DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE 12, KORONADAL CITY**, represented by the **Regional Executive Director, AMALIA J. DATUKAN, MBA** hereinafter called the **First Party** and **DEPARTMENT OF AGRICULTURE EMPLOYEES AND FARMERS MULTI-PURPOSE COOPERATIVE** with principal address at **CSA Bldg., Alunan Avenue, Koronadal City**, represented by its **Authorized Representative, CHITO DECENA**, hereinafter called as the **Second Party**;

**WITNESSETH**

**Whereas**, the **First Party** has a procurement of **Food Provision for the conduct of Farmer's Heart Day cum Mini Ulat sa Bayan** with the **Approved Budget for the Contract of One Million Seven Hundred Sixteen Thousand Pesos (Php1,716,000.00)**;

**Whereas**, a public bidding was conducted on February 9, 2016 with only one (1) participating bidders which was **Department of Agriculture Employees and Farmers Multi-Purpose Cooperative (DAEFMPC)** and was awarded the **Food Provision for the conduct of Farmer's Heart Day cum Mini Ulat sa Bayan** in the amount of **One Million Three Hundred Twenty Thousand Pesos (Php1,320,000.00)**;

**Whereas**, the **First Party** has accepted the bid of the **Second Party** in the amount of **One Million Three Hundred Twenty Thousand Pesos (Php1,320,000.00)** which shall be completely served on **February 23, 2016** at **DA-CEMIARC, Balindog, Kidapawan City** with the following specifications, to wit:

- 1 meal and 2 snacks
- 4,400 pax at P390.00 per pax

**NOW THEREFORE**, for and in consideration of the following premises, the parties hereto agreed as follows:

1. The following documents shall be deemed to form and be interpreted/construed as part of this agreement, viz:

- (a) Funded and Approved Purchase Request;
- (b) Advertisement;
- (c) Approved Notice of Award;
- (d) Performance Bond;
- (e) Bid form and the Price schedule submitted by the bidder;
- (f) Schedule of requirements;
- (g) Abstract of Bids for Bid project;
- (h) Resolution of the Bids and Awards Committee as the case may be; and
- (i) Other pertinent documents as may be reasonable required by the First Party.

2. The **First Party** hereby covenants to pay the **Second Party** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
3. Should the Second Party incurred delay, Section 68, Rule XXII of RA 9184, partly states, "Xxx. The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Xxx";
4. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
5. This agreement shall be valid and binding upon approval of both parties.






