**CONTRACT**  
**Negotiated Procurement**

This Agreement is made and entered this day MAY 03 2016, 2016 between the **DEPARTMENT OF AGRICULTURE-RFO XII, KORONADAL CITY, PHILIPPINES**, represented by its **Regional Executive Director, AMALIA J. DATUKAN, MBA.** hereinafter called the **"First Party"** and **SOUTH COTABATO SEED PRODUCERS MPC** with principal address at **Lower Balmores, Brgy. GPS, Koronadal City**, represented by its **Manager, ARNIE Z. ANIVERSARIO** hereinafter called the **"Second Party"**;

Whereas, the **First Party** invited a procurement for the supply and delivery of 24,285 bags Certified Palay Seeds (in support to HYTA Program 2016) and has accepted a Bid by the **Second Party** for the supply of those goods with the total amount of **Thirty-Three Million Twenty-Four Thousand Two Hundred Ninety-Seven Pesos and 24/100 (Php33,024,297.24)**.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to;
2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz:
  - a) Funded and Approved Purchase Request;
  - b) Advertisement;
  - c) License copy of contractor;
  - d) Performance Bond;
  - e) Bids and Abstract of Bids for Bid project;
  - f) Resolution of the Bids and Awards Committee as the case may be;
  - g) Approval of the Award by the Regional Director;
  - h) Letter of Acceptance of the winning bidder.
3. The **Second Party** hereby agrees to supply and deliver the 24,285 bags Certified Palay Seeds (in support to HYTA Program 2016) within **thirty (30) calendar days** at **NFA Warehouse, Tacurong City** with the following specifications, to wit:

**Specifications:**

- 40kg/bag
- NSIC Approved Variety
- Germination test should minimum of 85% (NSQCS standard)
- Germination testing before award and before delivery at designated drop-off point to be conducted by BPI-NSQCS.
- Packaging as prescribed by the BPI-NSQCS in green bag front and back printed with **"HYTA PROGRAM 2016", DA & Agri-Pinoy Logo** and **"NOT FOR SALE"** in 3 inches diameter

4. The **First Party** hereby covenants to pay the **Second Party** in consideration of the provision of the goods and services of high quality and efficiency and to remedy defects therein, the contract price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;



7. This agreement shall be valid and binding upon approval of both parties.




