This Agreement is made and entered this day _____ of _____, 2016 between the DEPARTMENT OF AGRICULTURE-RFO XII, KORONADAL CITY, PHILIPPINES, represented by its Regional Executive Director, AMALIA J. DATUKAN, MBA, hereinafter called the "First Party" and SOUTH COTABATO SEED PRODUCERS MPC with principal address at Lower Balmores, Brgy. GPS, Koronadal City, represented by its Manager, ARNIE Z. ANIVERSARIO hereinafter called the "Second Party";

Whereas, the First Party invited a procurement for the Line Item No. 1: Supply and delivery of 6,071 bags Certified Palay Seeds (in support to Technology Demonstration) and has accepted a Bid by the Second Party for the supply of those goods with the total amount of Eight Million Two Hundred Fifty-Five Thousand Seven Hundred Thirty-Four Pesos and 34/100 (Php8,255,734.34).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to;
2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz:
 - a) Funded and Approved Purchase Request;
 - b) Advertisement;
 - c) License copy of contractor;
 - d) Performance Bond;
 - e) Bids and Abstract of Bids for Bid project;
 - f) Resolution of the Bids and Awards Committee as the case may be;
 - g) Approval of the Award by the Regional Director;
 - h) Letter of Acceptance of the winning bidder.
3. The Second Party hereby agrees to supply and deliver the 6,071 bags Certified Palay Seeds (in support to Technology Demonstration) within thirty (30) calendar days at DA-CEMIARC, Tupi, Bololmalia, South Cotabato with the following specifications, to wit:

Specifications:

- Packed at 40kg per bag
- Should pass seed certification process with BPI-NSQCS
- Submit Seed Test Laboratory Result which should be within 3 months after harvest

4. The First Party hereby covenants to pay the Second Party in consideration of the provision of the goods and services of high quality and efficiency and to remedy defects therein, the contract price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;



5. Should the **Second Party** incur delay, Section 68, Rule XXII of RA 9184, partly states, "xxx.The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion of every day of delay. Xxx";
6. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
7. This agreement shall be valid and binding upon approval of both parties.






