CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered this NOV 27 2016 day of _____ by and between the **DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE 12, KORONADAL CITY**, represented by the **Regional Executive Director, ENGR. MILAGROS C. CASIS** hereinafter called the **First Party** and **P & J AGRICULTURAL TRADING, INC.** with principal address at **184 Dr. Sixto Antonio Avenue, Caniogan, Pasig City**, represented by its **Authorized Representative, JOHANNA LIN J. PINEDA-GUIANG**, hereinafter called as the **Second Party**;

WITNESSETH

Whereas, the **First Party** has a procurement for the **supply and delivery of Veterinary Drugs** with the **Approved Budget for the Contract of One Million Seven Hundred Six Thousand Six Hundred Eighty Pesos (Php1,706,680.00)**;

Whereas, a public bidding was conducted on September 27, 2016 with three (3) participating bidders in which the **supply and delivery of Veterinary Drugs** was awarded to **P & J Agricultural Trading, Inc.** being the bidder with the **Lowest Calculated Responsive Bid** in the amount of **Nine Hundred Thirteen Thousand Three Hundred Two Pesos (Php913,302.00)**;

Whereas, the **First Party** has accepted the bid of the **Second Party** in the amount of **Nine Hundred Thirteen Thousand Three Hundred Two Pesos (Php913,302.00)** which shall be completely delivered within **Thirty (30) calendar days** at **DA-RFO12, Brgy. Carpenter Hill, Koronadal City** upon receipt of the approved Notice to Proceed with the following specifications, to wit:

- 270 bottles OXY 20% LA
- 272 bottles ENRO 5%
- 270 bottles CBG 100 ml
- 272 bottles HEPAVITA 100 ml
- 272 bottles Vitamin ADE
- 272 bottles Multivitamins
- 271 bottles DECTOMAX 50 ml
- 272 bottles ANALGIN 30%
- 270 liters ALBENDAZOLE 15%

NOW THEREFORE, for and in consideration of the following premises, the parties hereto agreed as follows:

1. The following documents shall be deemed to form and be interpreted/construed as part of this agreement, viz:

- (a) Funded and Approved Purchase Request;
- (b) Advertisement;
- (c) Approved Notice of Award;
- (d) Performance Bond;
- (e) Bid form and the Price schedule submitted by the bidder;
- (f) Schedule of requirements;
- (g) Abstract of Bids for Bid project;
- (h) Resolution of the Bids and Awards Committee as the case may be; and
- (i) Other pertinent documents as may be reasonable required by the First Party.

2. The **First Party** hereby covenants to pay the **Second Party** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

3. The obligation of warranty shall be covered by retention money, in an amount equivalent to ten percent (10%) of the total contract price, or a bank guarantee in a form of an irrevocable stand-by letter of credit.

4. Should the Second Party incurred delay, Section 68, Rule XXII of RA 9184, partly states, "Xxx. The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Xxx";


5. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and






