### CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered this \_\_\_\_ day of JUN 30 2016 by and between the **DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE 12, KORONADAL CITY**, represented by the **Regional Executive Director, AMALIA J. DATUKAN, MBA** hereinafter called the **First Party** and **PHELA GRANDE HOTEL, INCORPORATED** with principal address at **Magsaysay Avenue corner Atis St., Brgy. Dadiangas, West, General Santos City**, represented by its **Authorized Representative, LUZ S. DECREPITO**, hereinafter called as the **Second Party**;

### WITNESSETH

Whereas, the **First Party** has a procurement of **provision of food and accommodation for the conduct of 2016 Regional Sikat Saka Rice Congress cum Trade Fair and Exhibits** with the **Approved Budget for the Contract of Five Hundred Thirty-One Thousand Pesos (Php531,000.00)**;

Whereas, a public bidding was conducted on June 1, 2016 with only one (1) participating bidder which was **Phela Grande Hotel, Incorporated** and was awarded the **provision of food and accommodation for the conduct of 2016 Regional Sikat Saka Rice Congress cum Trade Fair and Exhibits** in the amount of **Five Hundred Thirty-One Thousand Pesos (Php531,000.00)**;

Whereas, the **First Party** has accepted the bid of the **Second Party** in the amount of **Five Hundred Thirty-One Thousand Pesos (Php531,000.00)** which shall be completely provided on **August 2016** at **General Santos City** with the following specifications, to wit:

- 1<sup>st</sup> day - Full board
  - 300 pax at P1,300.00 per pax
  - Full board (3 meals and 2 snacks with accommodation)
  - Meals: 3 viands, soup, dessert, drinks, flowing coffee
  - Snacks: Any
- 2<sup>nd</sup> day
  - 300 pax at P470.00 per pax
  - 1 meal and 2 snacks
  - Meals: 3 viands, soup, dessert, drinks, flowing coffee
  - Snacks: Any


**NOW THEREFORE**, for and in consideration of the following premises, the parties hereto agreed as follows:


1. The following documents shall be deemed to form and be interpreted/construed as part of this agreement, viz:
  - (a) Funded and Approved Purchase Request;
  - (b) Advertisement;
  - (c) Approved Notice of Award;
  - (d) Performance Bond;
  - (e) Bid form and the Price schedule submitted by the bidder;
  - (f) Schedule of requirements;
  - (g) Abstract of Bids for Bid project;
  - (h) Resolution of the Bids and Awards Committee as the case may be; and
  - (i) Other pertinent documents as may be reasonable required by the First Party.
2. The **First Party** hereby covenants to pay the **Second Party** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
3. The obligation of warranty shall be covered by retention money, in an amount equivalent to ten percent (10%) of the total contract price, or a bank guarantee in a form of an irrevocable stand-by letter of credit.
4. Should the Second Party incurred delay, Section 68, Rule XXII of RA 9184, partly states, "Xxx. The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Xxx";
5. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
6. This agreement shall be valid and binding upon approval of both parties.


