DATUKAN, MBA. Hereinafter called the "First Party" and DJ ALUMINUM AND GLASS SUPPLY with principal address at Alunan Highway, Brgy. Poblacion, , represented by its Proprietor, IDELYNE P. MIRALLES hereinafter called the "Second Party";

Whereas, the First Party invited a procurement for the supply and delivery of Various Agricultural Materials and Equipment and has accepted a Bid by the Second Party for the supply of those goods with the total amount of Five Hundred Twenty-Five Thousand Three Hundred Seventy-Two Pesos and 50/100 (Php525,372.50).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to;
- 2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz:
 - a) Funded and Approved Purchase Request;
 - b) Advertisement;
 - c) License copy of contractor;
 - d) Performance Bond;
 - e) Bids and Abstract of Bids for Bid project;
 - f) Resolution of the Bids and Awards Committee as the case may be;
 - g) Approval of the Award by the Regional Director;
 - h) Letter of Acceptance of the winning bidder.
- 3. The Second Party hereby agrees to supply and deliver the Various Agricultural Materials and Equipment within thirty (30) calendar days at DA-CEMIARC, Bololmala, Tupi, South Cotabato with the following specifications, to wit:

 - Fuel tank capacity : 0.65 liter
- 2 units Rotavator blade
- 1 unit Submersible pump
 - \$ingle phase, 5HP
- 1 unit Water tank
 - Stainless steel, 500 galloon capacity



- 4. The First Party hereby covenants to pay the Second Party in consideration of the provision of the goods and services of high quality and efficiency and to remedy defects therein, the contract price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;
- 5. Should the Second Party incur delay, Section 68, Rule XXII of RA 9184, partly states, "xxx.The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion of every day of delay. Xxx";
- 6. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
- This agreement shall be valid and binding upon approval of both parties.
