**CONTRACT**

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered this 17 day of JUN 2016 by and between the **DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE 12, KORONADAL CITY**, represented by the **Regional Executive Director, AMALIA J. DATUKAN, MBA** hereinafter called the **First Party** and **JTM AGROCHEM** with principal address at **Public Market, Koronadal City**, represented by its **Proprietor, DEAN HARVEY R. MESA**, hereinafter called as the **Second Party**;

**WITNESSETH**

**Whereas**, the **First Party** has a procurement of **Various Chemicals** with the **Approved Budget for the Contract of One Million Pesos (Php1,000,000.00)**;

**Whereas**, a public bidding was conducted on April 12, 2016 with two (2) participating bidders in which **JTM Agrochem** won in the bidding and was awarded the **supply and delivery of Various Chemicals** in the amount of **Four Hundred Twenty-One Thousand Three Hundred Fifty Pesos (Php421,350.00)**;

**Whereas**, the **First Party** has accepted the bid of the **Second Party** in the amount of **Four Hundred Twenty-One Thousand Three Hundred Fifty Pesos (Php421,350.00)** which shall be completely delivered within **Thirty (30) calendar days** at **RCPC - Tacurong City** upon receipt of the approved Notice to Proceed with the following specifications, to wit:

- 5,000 sachet Rodenticide (acute) Zinc Phosphide at 10 grams per sachet
- 2,857 sachet Rodenticide (Chronic) Racumin at 10 grams per sachet
- 700 bottles Cypermethrin (1,000 mL per bottle)

**NOW THEREFORE**, for and in consideration of the following premises, the parties hereto agreed as follows:

1. The following documents shall be deemed to form and be interpreted/construed as part of this agreement, viz:

- (a) Funded and Approved Purchase Request;
- (b) Advertisement;
- (c) Approved Notice of Award;
- (d) Performance Bond;
- (e) Bid form and the Price schedule submitted by the bidder;
- (f) Schedule of requirements;
- (g) Abstract of Bids for Bid project;
- (h) Resolution of the Bids and Awards Committee as the case may be; and
- (i) Other pertinent documents as may be reasonable required by the  
 First Party.

2. The **First Party** hereby covenants to pay the **Second Party** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
3. The obligation of warranty shall be covered by retention money, in an amount equivalent to ten percent (10%) of the total contract price, or a bank guarantee in a form of an irrevocable stand-by letter of credit.
4. Should the Second Party incurred delay, Section 68, Rule XXII of RA 9184, partly states, "Xxx. The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Xxx";
5. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
6. This agreement shall be valid and binding upon approval of both parties.






