#### WITNESSETH

Whereas, the First Party has a project of Supply and delivery of 11,675 bags Hybrid Corn Seeds for North Cotabato and Sarangani Province with the Approved Budget for the Contract (ABC) of Forty-Six Million Seven Hundred Thousand Pesos (P46,700,000.00) at Four Thousand Pesos (P4,000.00) per bag;

Whereas, a public bidding was conducted last September 27, 2016 with two (2) bidders and Asian Hybrid Seed Technologies, Inc. represented by its Marketing Representative, Renfred B. Rabang was declared as Lowest Calculated Responsive Bid in the amount of Twenty-Six Million Seven Hundred Ninety-Four Thousand One Hundred Twenty-Five Pesos (Php26,794,125.00) at Two Thousand Two Hundred Ninety-Five Pesos (P2,295.00) per bag;

Whereas, the First Party has accepted the bid of the Second Party which shall be completed within thirty (30) calendar days at NFA-Warehouse in M'lang, North Cotabato upon receipt of Notice to Proceed, with the following specifications, to wit:

- Germination rate: 95% and above
- Purity rate: 97% and above
- Not more than 14% MC prior to sale and delivery
- Should pass Seed Testing Laboratory by BPI-NSQCS
- Yield potential: 5-6MT/ha
- NSIC Approved Variety
- Supplier should be BPI accredited seed grower/cooperative
- Packaging material: Printed sack with inner plastic (double lining)
  - With print out/sticker (water resistant) on the sack the following:
     a. DA logo (4 inches diameter)
- Delivery schedule :

Schedule of requirements;

g) Abstract of Bids for Bid project;

- h) Resolution of the Bids and Awards Committee as the case may be; and
- i) Other pertinent documents as may be reasonable required by the First Party.
- The First Party hereby covenants to pay the Second Party in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
- The obligation of warranty shall be covered by retention money, in an amount equivalent to ten percent (10%) of the total contract price, or a bank guarantee in a form of an irrevocable stand-by letter of credit.
- 4. Should the Second Party incurred delay, Section 68, Rule XXII of RA 9184, partly states, "Xxx. The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Xxx";
- 5. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
- 6. This agreement shall be valid and binding upon approval of both parties.
