WITNESSETH

Whereas, the First Party has a procurement of 900,000 cuttings Sweet Potato with the Approved Budget for the Contract of Nine Hundred Thousand Pesos (Php900,000.00);

Whereas, a public bidding was conducted on February 29, 2016 with only one (1) participating bidder which was Kooperatiba ng Magsasakang Pilipino ng Timog Kutabato (KOMATIKU) and was awarded the supply and delivery of 900,000 cuttings Sweet Potato in the amount of Nine Hundred Thousand Pesos (Php900,000.00);

Whereas, the First Party has accepted the bid of the Second Party in the amount of Nine Hundred Thousand Pesos (Php900,000.00) which shall be completely delivered within Thirty (30) calendar days at DA-CEMIARC Balindog, Kidapawan City upon receipt of the approved Notice to Proceed with the following specifications, to wif:

NOW THEREFORE, for and in consideration of the following premises, the partles hereto agreed as follows:

 - Approved Notice of Award; (c)
 - Performance Bond; (d)
 - Bid form and the Price schedule submitted by the bidder; (e)
 - Schedule of requirements; (f)
 - Abstract of Bids for Bid project; (g)
 - Resolution of the Bids and Awards Committee as the case may be; (h) and
 - Other pertinent documents as may be reasonable required by the (i) First Party.
- The First Party hereby covenants to pay the Second Party in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
- The obligation of warranty shall be covered by retention money, in an amount equivalent to ten percent (10%) of the total contract price, or a bank guarantee in a form of an irrevocable stand-by letter of credit.
- Should the Second Party incurred delay, Section 68, Rule XXII of RA 9184, partly states, "Xxx. The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Xxx";
- Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
- This agreement shall be valid and binding upon approval of both parties.
