Having entered into a contract with the Department of Agriculture, RFO 12, Zulueta Street, Koronadal City, you are hereby authorized to proceed with the supply and delivery of **Forty-Five (45) Units Pump and Engine Set- Open Source with ITB reference No. 3850445** in the amount of **Two Million Nine Hundred Two Thousand Four Hundred Ninety-Nine Pesos And 55/100 (Php2,902,499.55)** at **Sixty-Four Thousand Four Hundred Ninety-Nine Pesos and 99/100 (Php64,499.99) Per Unit** subject to the terms and conditions of the contract agreement, specifically the provision on Liquidated Damages (LD) as stipulated in RA 9184 with the following specifications, to wit:

a. Pump

- 4x4 centrifugal pump
- Min. discharge cap (30 lps)
- Suction lift off at least 8 meters
- Efficiency: at least 60%

b. Prime Mover

- Engine: diesel, single cylinder
- 8 HP, minimum(continuous power at least 80% of rated power)
- Cooling system: water cooled
- Manual cranking
- Specific fuel consumption at continuous power: 600g/kw-h

c. Accessories and Fittings

- 1 pc. 4"x8" GI nipple
- 1 pc. 4" diameter foot valve
- 4 pcs. hose clamps
- 1 pc 4" x 20" meters duct hose
- 2 pcs. V belt
- 2 pcs. pulley
- Pump and engine steel base
- 1 pc. 1 meter discharge pipe
