Having entered into a contract with the Department of Agriculture, RFO 12, Koronadal City, you are hereby authorized to proceed with the **supply and delivery of 666,667 pcs Cacao Planting Materials** in the amount of **Thirteen Million Three Hundred Thousand Six Pesos and 60/100 (Php13,300,006.60)** with **ITB Reference No. 3632448**, subject to the terms and conditions of the contract agreement specifically the provision on "LIQUIDATED DAMAGES" (LD) as stipulated in RA 9184 with the following specifications:


- Joint venture variety: UF 18 grafted (500,000 pcs) and BR 25 grafted (166,667 pcs)
- Potted in 6"x8"x0.003 black PE bag
- Minimum height: at least 0.5 meter
- Minimum age: 5-6 months old from budding
- Minimum # of leaves: 6 mature leaves
- The onion of the root stock and the scion are completely healed and free from plastic strips
- The scion must be compatible with the root stocks
- Free from sprouts growing below the onion
- No growing roots outside the bag
- Acclimatization period: 15 days
- Retention: 10% payment retention to be released after 3 months from delivery
- Mortality allowance: 5%
